

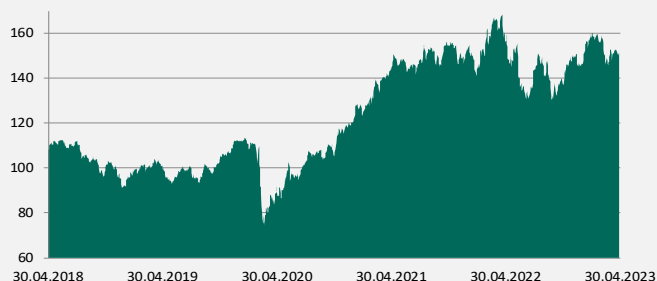

Performance over 5 years



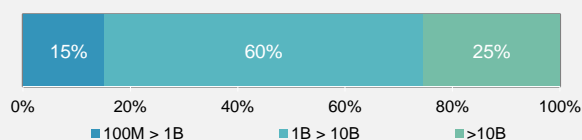

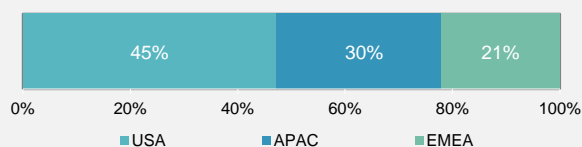

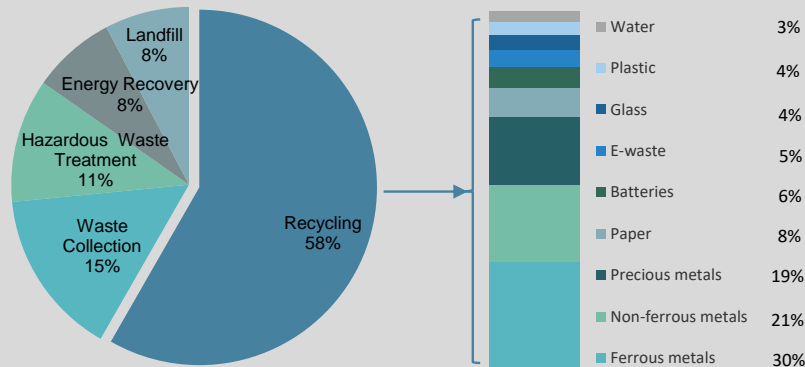
Split by size of companies
