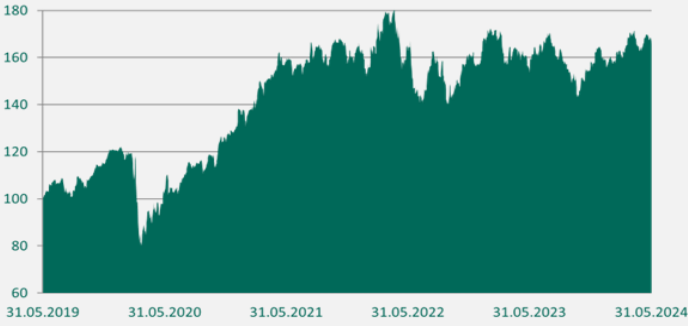

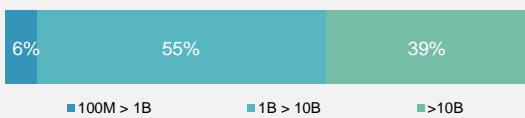

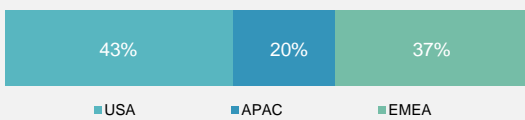

## Company market cap

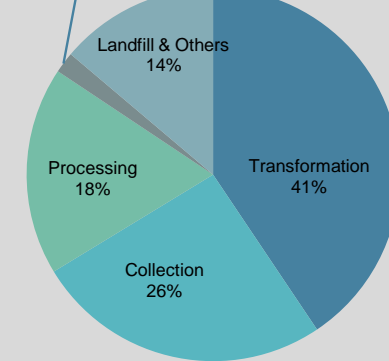


## Geographic split

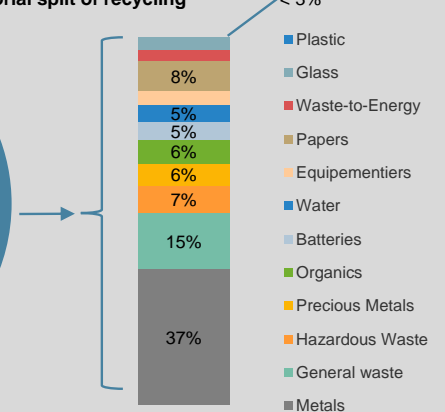
