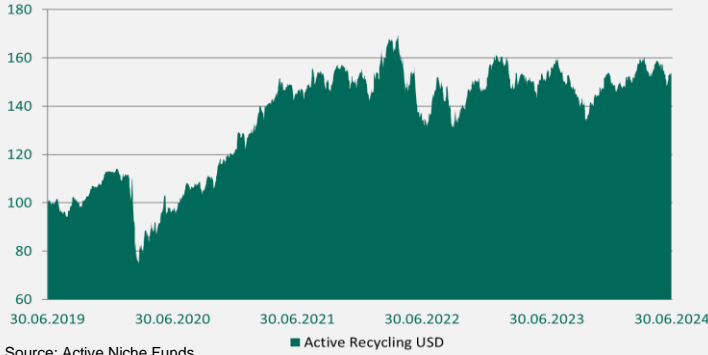

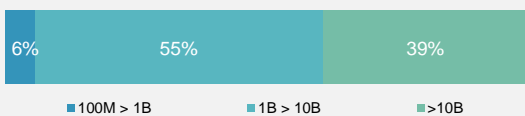

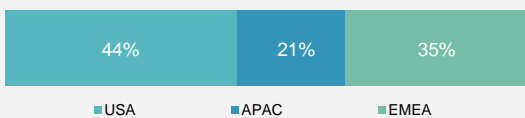

Company market cap

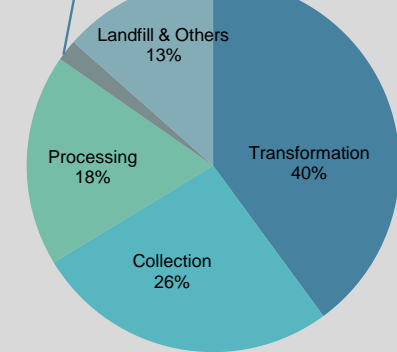


Geographic split

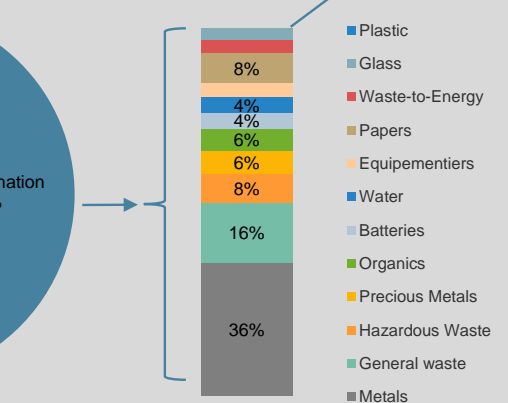
